**EXPLANATORY NOTES:**

**Voluntary Contributions**

A Contribution is "voluntary" and all money collected through Voluntary Contributions is used in accordance with the schedule shown on the previous page. Monies are put directly into these accounts to supplement monies received through the student-centred funding model. These accounts are used to purchase equipment and resources to support student learning across the learning areas. The monies received through Voluntary Contributions are an important part of the school's income stream and contribute directly to benefit the learning of all students. In accordance with the Department of Education Contributions Charges and Fees Policy September 2001, schools can request up to a maximum contribution of \$60.00 per student for years K - 6.

**Charges**

A **charge** refers to the provision of extra cost optional activities which are part of an educational program and which contributions do not cover. All of the following are optional and no if no payment received, an education activity with a similar outcome will be provided to that student.

The **2025 extra cost optional** activities, which have been approved by the School Board, are as follows. The estimated costs provided are at an upper limit and will not exceed this amount. If a particular event does not transpire within the school year, no charges for that event will apply. The School Board has approved all charges.

**Personal Requirements**

The Waddington Primary School Board has approved these Personal Items Requirements list, as items being required by students for personal use in the educational programs provided by the school.

**Financial Accountability**

The school accounts for and reports all monies received and expended through the Waddington Primary School Finance Committee, the School Board and all appropriate Financial Management processes including Audits.
